NEW LICENCE FEES

The Financial Services Commission ("FSC") has, under the Financial Services (Consolidated Licensing and Fees) (Amendment) Rules 2011, revised the annual fees and charges for late payment thereof applicable to:

Global Business Companies holding a Category 1 Licence ("GBL1") and
Corporate and Trust Service Providers.

GENERAL NOTES

• The new annual fees and charges are applicable as from 1 January 2012.

• Where a licensee has fully paid its annual fees for the financial year ending 30 June 2012, it shall not be required to pay any additional annual fee for the financial year ended 30 June 2012.
