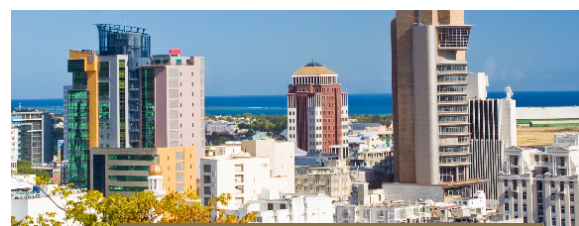
Blood Drive organised by ITL
